VI. Board Member Comments:

The Town Board extended their condolences to the family of Steve Lopez. He was icon in our parks, a smile for everyone, loved music, was a DJ for many Woodbury festivities, helped with dog swim, participated in Woodbury Day, Parks Commissioner, and worked for the Parks.

Councilwoman Hernandez spoke about the COVID numbers going up and the importance of wearing masks. She gave updates on the pool explaining that the Town Board actively engaged with contractors, pool engineer, town engineer, and the department of health. The department of health was extremely busy with COVID, retiring employees, and other issues. Contractors are ready to go, boring modifications have been approved, the Pool Engineer John Petroccione met with the department of health, and they are aware of our intentions to begin construction. Now we are waiting for the building department to give their approval. Hopefully, the pool will be ready for Memorial Day weekend. Worst case scenario it may encounter construction/weather delays.

Councilman Hunter noted how busy the Police Department was with their DWI details and Officer Farahvashi doing the commercial vehicle details.

Councilman Burke spoke about the pool construction and another huge project, the Court House restorations which have been taking place. Safety is paramount to us, and we have had scheduling delays because of the backlogged orders. Councilman Burke went onto say what an outstanding job was done this summer by Joe Gianzero, the Buildings and Grounds Department, lifeguards, gate keepers, and camp personnel who work for the Parks Department.

Working Leader Gianzero announced that the last day of Camp Rez is tomorrow with a magic show, balloons, and pizza. He will have his annual summer report for the next meeting.

Supervisor Palermo gave an update on the Court House. He explained that the insulation on the outside of the building was completed today, and the windows were taped up. The contractor filled in cracks and fixed that back wall. They are waiting on the new windows. The steps can only be worked on during the weekend because two ways of egress must always be available to the occupants. Supervisor Palermo is very happy with the contractors. He also wants to extend a special thanks to Colin Campbell from SSQ for allowing the contractor to use his property, when necessary. Supervisor Palermo also expanded on the conversation regarding the pool. The previous county pool inspectors for the Department of Health have retired. Therefore, John Petroccione our pool engineer is working with the department of health and showing them each step of the pool process.
