Presentation for Recognition and Accomplishment; Violette Kline:

The New York Attorney General's Office has a Triple C Award program to recognize the courage, character and commitment of New York State's outstanding students. The award was established to honor student displaying leadership skills and/or overcoming personal obstacles. Violette Kline is a recipient of this award this year. Supervisor Palermo presented Violette with a certificate.

Presentation for Appreciation and Recognition; Jared Bouachri:

For his Eagle Scout project, Jared Bouachri choose to assist the Town and County with the erection of the kiosk regarding the Moodna Watershed Council at Earl's Reservoir. Councilwoman Hernandez presented Jared with a certificate.

Presentation of 20th Anniversary Recognition; Kristine Porcu and Elizabeth Vetere

Kristine Porcu and Elizabeth Vetere were presented with certificates by Director Gianzero for twenty years of service to Woodbury in the Parks Department. He noted 20 years ago Camp Rez was created and during that time about 6000 kids were enrolled and many counselors employed, but the one constant was Kristine and Elizabeth.

I. Public Input:

Sandra Capriglione asked if the Board has any plans for the Gasho property and Supervisor Palermo stated he does not. Money was expended to repair the access road for the property since it is owned by the Town and the Town's responsibility to maintain it. Mrs. Capriglione then stated at the July meeting the Board approved spending \$3500 for beaver removal and if that was done on Town property. Supervisor Palermo stated no it was done by Bond Street and the Village is actually responsible for the maintenance of the wall there. Mrs. Capriglione said the invoice was for \$4400 and Supervisor Palermo stated more work was needed then what was expected (repairs were needed). Mrs. Capriglione then asked about the estimate for the pool and how long that would be bonded for and Supervisor Palermo stated it would be for fifteen years. Mrs. Capriglione then asked about the contract for the SRO's. Supervisor Palermo stated the agreement with the school involving the full-time SRO runs January thru December to coincide with the PBA contract. The agreement for the part-timers runs July 1 - June 30 and is for two years.

Susan Ciriello asked if the Board can provide a dollar amount for the legal fees for the litigation against the Village. Supervisor Palermo stated the Town has created a dedicated line-item for this charge (A1420.414) and year-to-date has spent \$63,005. Mrs. Ciriello stated she has FOILed the invoices and conducted an analysis. Since the litigation began she estimates the Town has spent about \$130,000 (she offered to provide Supervisor Palermo with a copy of her analysis). She asked if there was a cap placed on the cost of this litigation. Supervisor Palermo stated one was not and Councilwoman

Hernandez added it is very difficult to put a cap on something that is ongoing and involves investigation. She noted the Board is concerned about spending taxpayer money and they try to be frugal. She noted the Town has made public their position on this litigation and why they choose to pursue it. Since an agreement has not been met the judge has ruled the case needs to either proceed or be dropped. Supervisor Palermo added tonight the Board will be meeting to discuss this issue. The depositions have been completed and he believes a lot of information will be made public. He noted the Board is not afraid of it. Mrs. Ciriello asked what is the gain at the end of the day to the taxpayers and Supervisor Palermo stated what was done was done wrong, which was admitted by those people under oath.

Maria Hunter thanked the Town Board and the School District for working together to acquire additional SRO officers so that parents can be put at ease and everyone can be comfortable in the school district.
